## BREASTFEEDING IN WIC

The Citizen Potawatomi Nation WIC breastfeeding initiation rates increased by **259 percent** between 2004 and 2020.



Among WIC infants who initiated breastfeeding in the Citizen Potawatomi Nation in 2020, **18 percent** continued breastfeeding at 6 months.

## CHILDHOOD OBESITY IN WIC IN THE CITIZEN POTAWATOMI NATION

Childhood obesity rate, WIC toddlers, 2020..... **15%**



**Fruit and Vegetable Benefit:** Congress enhanced WIC's fruit and vegetable benefit to align with scientific recommendations. Current monthly benefit amounts are \$26 for children, \$47 for pregnant and postpartum participants, and \$52 for breastfeeding participants. In FY 2023, WIC provided an estimated **\$400,944** in fruit and vegetable benefits to **1,101** participants in the Citizen Potawatomi Nation.
