of WIC infants in Five Sandoval Pueblos initiated breastfeeding in 2020.

Among WIC infants who initiated breastfeeding in Five Sandoval Pueblos in 2020, 18 percent continued breastfeeding at 6 months.



Fruit and Vegetable Benefit: Congress enhanced WIC's fruit and vegetable benefit to align with scientific recommendations. Current monthly benefit amounts are \$26 for children, \$47 for pregnant and postpartum participants, and \$52 for breastfeeding participants. In FY 2023, WIC provided an estimated \$41,709 in fruit and vegetable benefits to 115 participants in Five Sandoval Pueblos.
