Dear Chairman Pryor and Ranking Member Blunt:

We respectfully ask that you fully fund the Special Supplemental Nutrition Program for Women, Infants, and Children (WIC) in the Fiscal Year 2015 Agriculture Appropriations bill and assure the WIC contingency fund is adequately funded. Fully funding WIC ensures that no eligible applicants are turned away and that the program has the funds to ensure timely and responsible program management.

WIC is the nation's premiere preventive public health nutrition program serving nearly 9 million low income mothers and young children at nutritional risk. Numerous studies show that WIC saves money by improving birth outcomes and reducing pre-term and low birth weight babies. For example, for every dollar spent on a pregnant woman in WIC, up to \$4.21 is saved in Medicaid for her and her newborn baby. Since 1997, Appropriators of both parties have recognized the great value WIC adds to the nation's nutritional health and ensured that WIC has had sufficient funding to serve all eligible mothers and young children who apply.

We also request that you provide the following set asides, which will ultimately contribute to increased program integrity and long-term deficit reduction:

- \$96.2 million in set aside funding for breastfeeding peer counselors and breastfeeding support services;
- \$32.07 million in management information systems (MIT) and electronic service delivery systems (EBT) funding;
- \$14.96 million in infrastructure funding; and
- \$5 million for research

In addition to providing healthy foods, WIC provides critical health and social service referrals. As a result, children enrolled in WIC are more likely to be immunized on time, consume key nutrients, and have higher cognitive development scores than their peers not participating in WIC. Breastfeeding rates among WIC women are at record highs—63% initiation and 20% at 6 months. Removing families from the program as a result of funding cuts deprives young children of access to healthy food, a healthy start in life, and the opportunity to thrive.

We strongly urge you to fully fund WIC in the FY 2015 Agriculture Appropriations bill so they may continue to protect low-income mothers, infants, and children from hunger and improve their ability to access nutritious, balanced diets.
