BREASTFEEDING IN WIC

North Dakota WIC breastfeeding initiation rates increased by 29 percent between 2010 and 2020.

2010 59% 2020 76%

Among WIC infants who initiated breastfeeding in North Dakota in 2020, **25 percent** continued breastfeeding at 6 months.



Fruit and Vegetable Benefit: Congress enhanced WIC's fruit and vegetable benefit to align with scientific recommendations. Current monthly benefit amounts are \$26 for children, \$47 for pregnant and postpartum participants, and \$52 for breastfeeding participants. In FY 2023, WIC provided an estimated \$2.9M in fruit and vegetable benefits to 8,002 participants in North Dakota.
