### BREASTFEEDING IN WIC

Pennsylvania WIC breastfeeding initiation rates increased by **22 percent** between 2010 and 2020.



Among WIC infants who initiated breastfeeding in Pennsylvania in 2020, **13 percent** continued breastfeeding at 6 months.



**Fruit and Vegetable Benefit:** Congress enhanced WIC's fruit and vegetable benefit to align with scientific recommendations. Current monthly benefit amounts are \$26 for children, \$47 for pregnant and postpartum participants, and \$52 for breastfeeding participants. In FY 2023, WIC provided an estimated **\$48.5M** in fruit and vegetable benefits to **130,790** participants in Pennsylvania.

### CHILDHOOD OBESITY IN WIC IN PENNSYLVANIA

There was no significant change in the obesity rate among WIC toddlers in Pennsylvania between 2010 and 2020.
