BREASTFEEDING IN WIC

Rhode Island WIC breastfeeding initiation rates increased by 29 percent between 2010 and 2018.





Fruit and Vegetable Benefit: Congress enhanced WIC's fruit and vegetable benefit to align with scientific recommendations. Current monthly benefit amounts are \$26 for children, \$47 for pregnant and postpartum participants, and \$52 for breastfeeding participants. In FY 2023, WIC provided an estimated \$5.0M in fruit and vegetable benefits to 13,380 participants in Rhode Island.

There was no significant change in the obesity rate among WIC toddlers in Rhode Island between 2010 and 2020.
