## BREASTFEEDING IN WIC

The Santee Sioux Nation WIC breastfeeding initiation rates increased by **92 percent** between 2014 and 2020.



## CHILDHOOD OBESITY IN WIC IN THE SANTEE SIOUX NATION

Childhood obesity rate, WIC toddlers, 2020..... **25%**



**Fruit and Vegetable Benefit:** Congress enhanced WIC's fruit and vegetable benefit to align with scientific recommendations. Current monthly benefit amounts are \$26 for children, \$47 for pregnant and postpartum participants, and \$52 for breastfeeding participants. In FY 2023, WIC provided an estimated **\$10,802** in fruit and vegetable benefits to **30** participants in the Santee Sioux Nation.
