#### **BREASTFEEDING IN WIC**

Tennessee WIC breastfeeding initiation rates increased by **190** percent between 1998 and 2020.

1998 22% 2020 64%

Among WIC infants who initiated breastfeeding in Tennessee in 2020, 18 percent continued breastfeeding at 6 months.



Fruit and Vegetable Benefit: Congress enhanced WIC's fruit and vegetable benefit to align with scientific recommendations. Current monthly benefit amounts are \$26 for children, \$47 for pregnant and postpartum participants, and \$52 for breastfeeding participants. In FY 2023, WIC provided an estimated \$36.5M in fruit and vegetable benefits to **95,261** participants in Tennessee.
