Please reference National WIC Association 2020 Winter Board of Directors Meeting when calling to get the negotiated room rate, which is the prevailing Federal Per Diem currently set at \$166.00 per night, plus applicable state and local taxes of 14% single/double occupancy and is subject to change without notice. In addition, there is a \$2.00 charge per room/per night taxable Destination Fee for Charleston Area Convention and Visitors Bureau.

You may cancel your room reservations three (3) working days prior to your arrival date without penalty and a cancellation number provided.
