### BREASTFEEDING IN WIC

Wisconsin WIC breastfeeding initiation rates increased by **7 percent** between 2010 and 2020.



Among WIC infants who initiated breastfeeding in Wisconsin in 2020, **20 percent** continued breastfeeding at 6 months.



**Fruit and Vegetable Benefit:** Congress enhanced WIC's fruit and vegetable benefit to align with scientific recommendations. Current monthly benefit amounts are \$26 for children, \$47 for pregnant and postpartum participants, and \$52 for breastfeeding participants. In FY 2023, WIC provided an estimated **\$25.7M** in fruit and vegetable benefits to **70,592** participants in Wisconsin.

### CHILDHOOD OBESITY IN WIC IN WISCONSIN

There was no significant change in the obesity rate among WIC toddlers in Wisconsin between 2010 and 2020.

Childhood obesity rate, WIC toddlers, 2020..... **15%**

Maternal mortality per 100,000 births, 2017-2021... **10.8**

Infant mortality per 1,000 live births, 2021..... **5.4**

Preterm birth rate, 2021..... **10%**
