### BREASTFEEDING IN WIC

Wyoming WIC breastfeeding initiation rates increased by **5 percent** between 2010 and 2020.



Among WIC infants who initiated breastfeeding in Wyoming in 2020, **26 percent** continued breastfeeding at 6 months.



**Fruit and Vegetable Benefit:** Congress enhanced WIC's fruit and vegetable benefit to align with scientific recommendations. Current monthly benefit amounts are \$26 for children, \$47 for pregnant and postpartum participants, and \$52 for breastfeeding participants. In FY 2023, WIC provided an estimated **\$2.1M** in fruit and vegetable benefits to **5,672** participants in Wyoming.

### CHILDHOOD OBESITY IN WIC IN WYOMING

There was no significant change in the obesity rate among WIC toddlers in Wyoming between 2010 and 2020.

Childhood obesity rate, WIC toddlers, 2020..... **12%**
